Attention: All NEET- MDS 2019 Candidates

1. The result of NEET-MDS 2019 was declared on 14th January 2019. In accordance with Ministry of Health & Family Welfare, Govt of India letter F.No.V.12025/82/2018-DE dated 03rd April 2019, the minimum qualifying percentiles have been lowered [in pursuance of the 2nd Proviso in clause 7(1) of DCI, Master of Dental Surgery Course (1st Amendment) Regulations, 2018] as follows:
